DESCRIPTION:

- 1.- Exterior excavation to create access to existing cast sewer line for saw-cut and replacement of section of pipe up to 3' out from foundation, includes saw cut and replacement with fitting. \$150
  2. Remove approximately 6" of dirt from under the concrete walls on north wall. \$300.
  - 2 Excavate for approximately 60' of foundation for perimeter French drain sloping to existing sump drain. Includes drain pipe, mesh cloth cover, and gravel fill. \$750
  3. Level dirt base for concrete at 14.5 inches below top of slab using #5 road base recycled concrete and spread approximately 2" thick throughout 1200 square ft. floor area. \$1200
  4. Compact road base and cover with plastic. \$175
- All work to meet or exceed codes.
